2018-2019 Off-Season (LONG TERM) Vehicle Parking Program Release and Waiver for Liability and Indemnity Agreement

I, _____, the undersigned, a patron of the off-season parking program and a valid and current member of the Orange Hunt Swim Club, Inc. (hereinafter "OHSC") acknowledges that OHSC is extending a special privilege in allowing OHSC Members to park his or her **vehicle** during the off-season dates provided below in a designated section of the OHSC parking lot located at 8600 Bridle Wood Drive, Springfield, Virginia 22152. In consideration of the privilege to store a **vehicle** on OHSC premises, the undersigned, for himself or herself and any personal representative, heirs, and next of kin, hereby acknowledges, agrees and represents the following:

RELEASE: I agree to release, waive, discharge, and covenant not to sue the OHSC, its directors, officers, members, employees, and agents from all liability to me, my personal representative, heirs, and next of kin for any loss, theft, or damage, and any claim or demands therefore on account of injury to my property or person, whether caused by the negligence of the OHSC or otherwise during the dates provided below.

INDEMNIFICATION: I agree to indemnify and save and hold harmless the OHSC, its directors, officers, members, employees, and agents from any loss, liability, theft, damage or cost that may incur due to my storing my **vehicle**, upon or about the OHSC premises whether caused by the negligence of the OHSC or otherwise.

ACCEPTANCE OF RISK: I understand that the OHSC never intended, nor designed the parking lot to be used as a **storage** facility and I acknowledge that the OHSC does not guarantee the security of the property being parked on its premises. I agree to assume full responsibility for and risk of property damage due to the negligence of the OHSC or otherwise while my vehicle is parked during the dates provided below. I further acknowledge and understand that NO snow and/or ice removal is performed in the off-season and that the lot may be inaccessible to persons or vehicles for a period of time after a snowfall I further agree to not require OHSC to clean, clear or otherwise remove any snow or ice from its premises or my vehicle during the off-season.

OFF-SEASON DATES: I understand that the off-season dates for the purposes of this program are September 29, 2018 through May 13, 2019.

SECURING THE PREMISES: I understand that each OHSC off-season parking patron will receive the combination for the gate lock granting vehicle access to the OHSC parking lot. Access to the lot is only allowed from **8 AM to 9 PM**. Should an individual access the lot outside of these hours, their access to the lot will be revoked. I agree to relock and secure the OHSC parking lot gate each time I enter and exit the OHSC premises. I further agree that all vehicles (e.g., Boat, Trailers, RV, Vehicles) parked on OHSC premises will be road worthy and properly registered and insured.

PARKING POLICY: Any vehicle parked on OHSC premises will be winterized and secured in such a manner that will prevent any runoff to the OHSC premises. In the event of any vandalism to the vehicle or any part of the vehicle, the vehicle owner shall have the vehicle removed promptly. I also understand that all vehicles being parked on premises are permitted access from September 29th - May 13th. Any Vehicle left after May 13th may be towed at the patron and/or vehicle owner's expense.

GOVERNING LAW: Inclusive of the foregoing, I understand that any interpretation of this agreement will be governed under the laws and regulations of the State of Virginia, will be subject to arbitration and that I waive any right to assert or litigate this agreement in any court of law.

CONTACT PERSON: I agree to provide an alternative contact person and a phone number in my absence so that, in the event of an emergency, the contact person will be responsible for my vehicle.

Note: In the event of inclement weather (e.g., winter storm warning or accumulating snow or ice) a patron's vehicle may remain on premises until the lot is either plowed to allow access or cleared naturally. OHSC will neither tow, remove, nor impose additional charges under such circumstances. The patron's vehicle must be removed within 24 hours after inclement weather has cleared.
